President Mike Hobig

Gear:

Bylaws: Carol has some changes identified to portion of the bylaws. It seems that Education is not a term some care to change but I think we should continue to remove: "school" language from our bylaws.

To that end would like discussion to start on minimally the name and process of notification to members of change and what else SC has to do to make this happen.


(from Jenn T) The rules for how to change the Bylaws are in the Bylaws. You do not have to have a Bylaws Chairperson in order to change them. Anyone on the Steering Committee can propose a change to the Bylaws, but that exact change needs to be provided to the rest of the Steering Committee at least 5 days in advance of voting on it, and in writing (email suffices).

The trickiest part is making sure there is a current version of the Bylaws saved someplace where people can access it; ideally in a few places to make sure it isn't accidentally deleted entirely. I don't know where the most recent version is kept.

Saint Paul's Access: Carol was sent a reminder that if Livonia Public Schools are closed for snow days – St. Paul's is closed for the entire day and evening – no exceptions. It is unlikely to affect your group – but not impossible

Still would like to modify Voting Box: Had talk with Stacie, she said she has capability for making vinyl version of logo, I want to find out if we can make a new 9 x 9 inch max version for the side of the voting box. (Voting box currently has old logo which I plan to keep and S.O.L.A.R. on top, I hope to color out the dots, do we know who painted it last from yellow to get matching paint)

Education Carol McCririe

- The only workshop pending is the beginning backpacking which starts next month.
- I am working on a draft of the procedures to run a workshop. Krisanne sent me a document that was developed for activities so that the two can be in sync for meetup, etc.
- It has been suggested that we need to change the name from education to ??? I feel that this isn't necessary; education can be defined as the sharing of knowledge, and that is basically what the workshop leaders do they share knowledge from experience.
- Discussion and about Education. We continue to remove the word class to workshop and that education is still appropriate for our workshops and sharing of knowledge.

Equipment Chair Phil Crookshank

I spent 6 hours last week in the gear room, sorting through a lot of equipment that didn't sell at the picnic - a big pile (15) of lightweight climbing or mountaineering harnesses that were so old they were stiff went, along with old storage bags for different things that got no interest at the sale. I eliminated another backpack that was 6#, and so full of zippers, straps, pouches, hidden pockets, that it was maddening to try to get it all working. And the most important strap - to adjust and hold the torso length was missing. Also hidden inside that pack was the missing 311 new B.A. sleeping pad, so now we have another one to lend.

I spent a lot of time measuring all of our components in the room, and know that the large high, table that I made to fit into one corner, with room for 6 big tubs underneath, and all the winter shovels, snowshoes, poles, etc, on top - - - that table will have to go.

Lets see if anyone would like it for a garage storage shelf - the hood of a car could slide underneath it, with storage on top. Also, all the winter stuff on top of the table must go.

And there are **7 large tubs** of party decorations, tablecloths, table decorations, 24 glass jars for candles, and literally hundreds of all sizes paper plates, cold drink cups, hot drink cups, 5,000 napkins, and on and on. Also a big tub with real silverware that was collected for the 45th reunion party. Do we really need 500 each of forks, spoons, knives? And a tub of pretty big picnic B.B. Q. tools, gloves, etc. Most all of that should be parcelled out somewhere, of we won't be able to downsize to a 10 x 10 room. i've made a chart of how all the shelving we have will fit into 10 x 10, and the backpack hanging pole will be cut down to be slightly less than 10'. I will make some adaptors to hang the pole off of the shelving units, since there are only sheet metal walls in the units.

So - I would like to plan to start moving out in the first week of August. And **start** to move in to the Clover unit by the 2nd week of August. Clover has a small U-hall truck we get to use for the big shelving units, and much of the shelving contents.

I will need a few days in advance **Stage 1** to get the 12" square shelving unit over to Clover first, cut the pole down to length, make up some wooden supports for the pole - to the floor, and also sideways to be attached to a shelving unit. Once that is in place, then one big move will get the rest moved. Lets talk about helpers to move - - 2 of us can move the **Stage 1** stuff as mentioned above. Then several days for me to get the backpack pole, and shelf attachments made, then one big move **Stage 2** needing 5 or 6 people, by the 3rd week of August, done by the last of August.

So - Jon (treasurer) do you have the credit card to pay for one more month at Storage Sense? Unit 1414. Pay anytime before the 28th of July, and that will carry us through.

They email the receipt to me, and I can forward to you.

AND - Steering Committee - are we in agreement to move to Clover in August? If so, I'd like to have Jon start our contract by the 2nd week August 2. I would meet with them again, in a week, and finish the details, and start the contract.

Public Relations Bob Tacy

Webmaster

- Requested that my programmer create the four pieces of code needed for Stacie to add a link to PayPal for paying dues, making equipment deposits, donating and attending events.
- Sent a test of \$1.00 to the PayPal email. Since former treasurer Carol only received \$.48 after \$.52 was taken in fees, I recommend we change membership dues to \$6.00 when paid online.
- Discussion about: How can we recoup fee for only services? Do we need to increase membership fees? Meetup and Stripe are the same company. Carol can manually move money from Meetup to Solar but has not seen a way to do this with Stripe.

Communications/Public Relations

- Created and boosted the Beginning Backpacking Workshop Facebook post.
 - The first ad targeted at followers and their friends ran from June 22 to July 7. It spent \$15 and generated 305 people and received 103 post engagements.
 - The second ad targeted to 25-64 year olds interested in adventure travel, ecotourism, mountains, mountain biking, camping or nature started July 12 and will run to the 29th. It will spend \$20. Through the 16th it has reached 1,114 people and received 38 post engagements.
- Text Magic account has \$134.56. Schedule a meeting with Jennifer Tislerics to learn more? Do members provide their cell phone numbers? Do we need their permission to send them text messages? Bob talked about having other people have access text to get our money's worth. Do we have permission to send texts people? Can Jennifer tell how big the list is, are their former members on the list? Stacie has access to see the text magic list which she will send to Bob to compare to current membership list.

Programs

- Carol is providing video of Leslie to create a 5-minute update on her AT trip. I am putting

- Created a Facebook post about the 4 presentations on July 14th. It has reached 474 people and has had 69 engagements. Do we want to spend \$35 over the next 7 days to promote the post to followers of the page to generate some meeting attendance?
- The steering committee is doing a great job of working together to fulfill the duties of this open position. Attached is the latest update of our progress toward getting speakers for the open positions.

- Have 26 people signed up for the Kayaking Event on the 30th.
