- My report hasn't changed much other than the Hammock Workshop wrapped up. Eight people signed up, but only 4 were able to attend. Jeff was a wealth of information.
- I believe that the only other item was Basic Land Nav Workshop, Carol reserved the room for the lectures.
- Discussion about other meeting rooms. Spicer House is not available any longer. Laura to see if there are other meeting rooms at the Heritage Park Nature Center building.

Equipment Chair Jeff McWilliams

- I will be out of town for the September meeting.
- I've written up detailed instructions on how to set up the AV equipment and how to run the LiveStream, and sent it to Beverly, Jim K, and Bob Tacy.
- Don't be upset if you can't figure out how to successfully run the LiveStream in my absence. It's complicated and I haven't had time to identify a backup person whom I could train. I've barely figured out the full setup myself and we still work through minor "glitches" each time we set up for a presentation.
- Mary W to pick up AV equipment for the meeting and Laura will help set it up. We will see if we set up the live stream for the presentation.

Equipment stuff:

- The equipment list on the website now points to my "live" Google Doc. It's a better, tabbed organization than the old multi-page PDF, and it shows the current status of all equipment. Thank you Jeff for all your work to get this up and running.
- Following the conclusion of the Hammock Camping workshop, there is now a dedicated tab on the equipment list for hammock gear. (See image below).
- I used some of the Hammock Workshop funds to purchase a 3rd, lighter hammock (TNT-24), and I sewed a tarp (TP-16) to accompany it.
- I upgraded the suspensions on the old Hennessy Hammocks from their old tree strap and rope system to modern straps and cinch buckles, and all three hammocks now have under quilts, albeit synthetic ones.
- (UQ-1, UQ-2, UQ-3) UQ-3 was my personal underquilt before upgrading to a light down quilt this past spring. I don't need two hammock underquilts in my closet.
- I'm still making some adjustments to the new hammock & underquilt to prevent drafts by sewing some additional clip points. The participant who used this combo during the workshop reported that the underquilt tended to slip to the side, creating some cold drafts at night. The additional attachment points will make the setup more foolproof. I have something similar on my personal hammock setup.
